As the data controller, our company has prepared this application form for information in order to enable the Related Persons to exercise these rights and to fulfil the disclosure obligation set out in Article 10 of the KVKK.

In accordance with Article 11 of the KVKK, you may use your following rights by applying to Makyol and filling out the attached form:

- a) You may find out whether your personal data has been processed,
- b) You may ask for details if your personal data has been processed,
- c) You may find out the purpose of processing your personal data and whether they have been used for their intended purpose,
- d) You may find out the third parties to whom your personal data has been transferred in the country or abroad,
- e) You may ask for correction if your personal data are incomplete or has been incorrectly processed,
- f) You may ask for the deletion or destruction of your personal data within the framework of the conditions stipulated in Article 7 of the KVKK,
- g) You can request that the third parties to whom your personal data have been transferred be notified of the actions taken in accordance with subparagraphs (e) and (f) above,
- h) You may object to the emergence of any results against you obtained through analysis of the processed data exclusively by means of automated systems, and
- i) In case you suffer any damages due to the processing of your personal data in violation of KVKK, you may ask for the compensation of such damages.

Pursuant to Article 13 of the KVKK, data subjects must submit their requests to our Company in writing or by other methods as designated by the Personal Data Protection Board ("**Board**"). In this context, applications to be filed to our Company can be sent to us free of charge by choosing either of the following two methods after filling out this form.

It is not possible for third parties to use, on behalf of data subjects, the right to obtain information which is regulated in article 11 of the KVKK. In order for a data owner to make a request for personal data relating to any person other than the data subject, a wet signed and notarized original copy of a special power of attorney issued by the data subject on behalf of the applicant must be submitted.

Your applications submitted to us will be answered within thirty days from the date your request is received by our Company in accordance with the Article 13/2 of the KVKK. Our responses will be delivered to you in written or electronic form in accordance with Article 13 of the KVKK.
